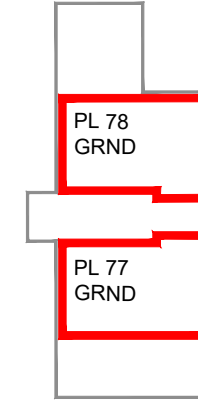

Ground floor



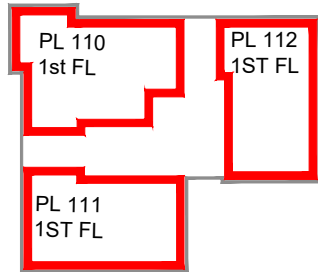
Plot 83 - 94
Ground floor



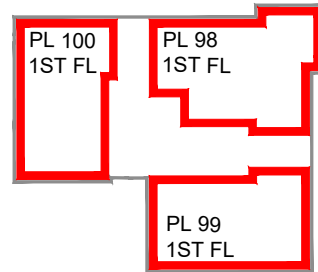

Ground floor



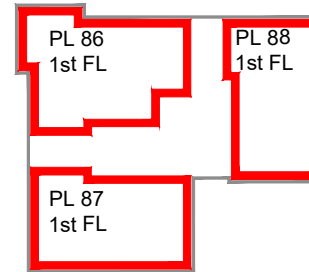

1st Floor



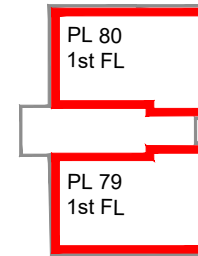

1st floor



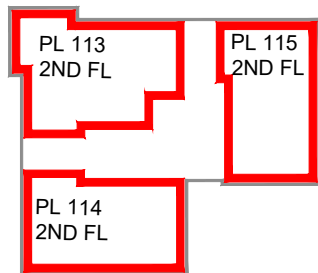

1st floor



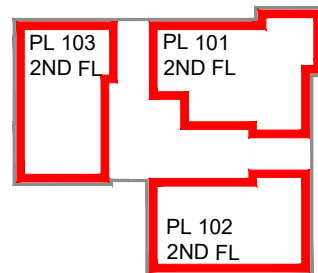

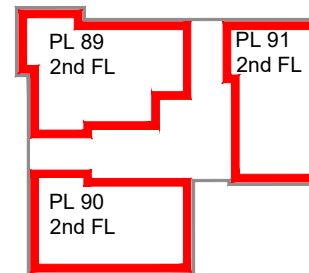

2nd Floor



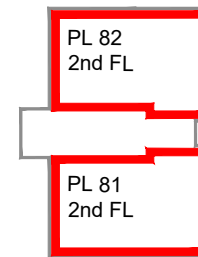

2nd floor



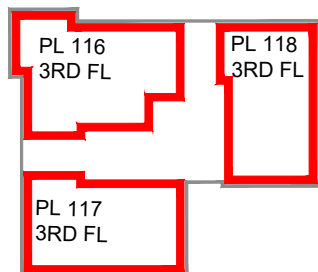

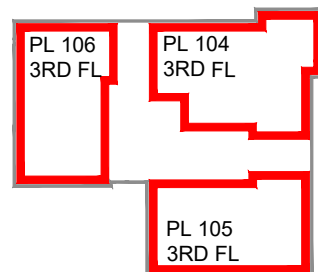

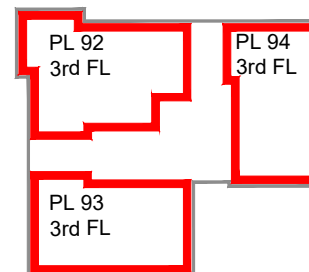
