PENNYWELL PHASE 3 - BLOCK C - GROUND FLOOR PLOT 62 TITLE PLAN

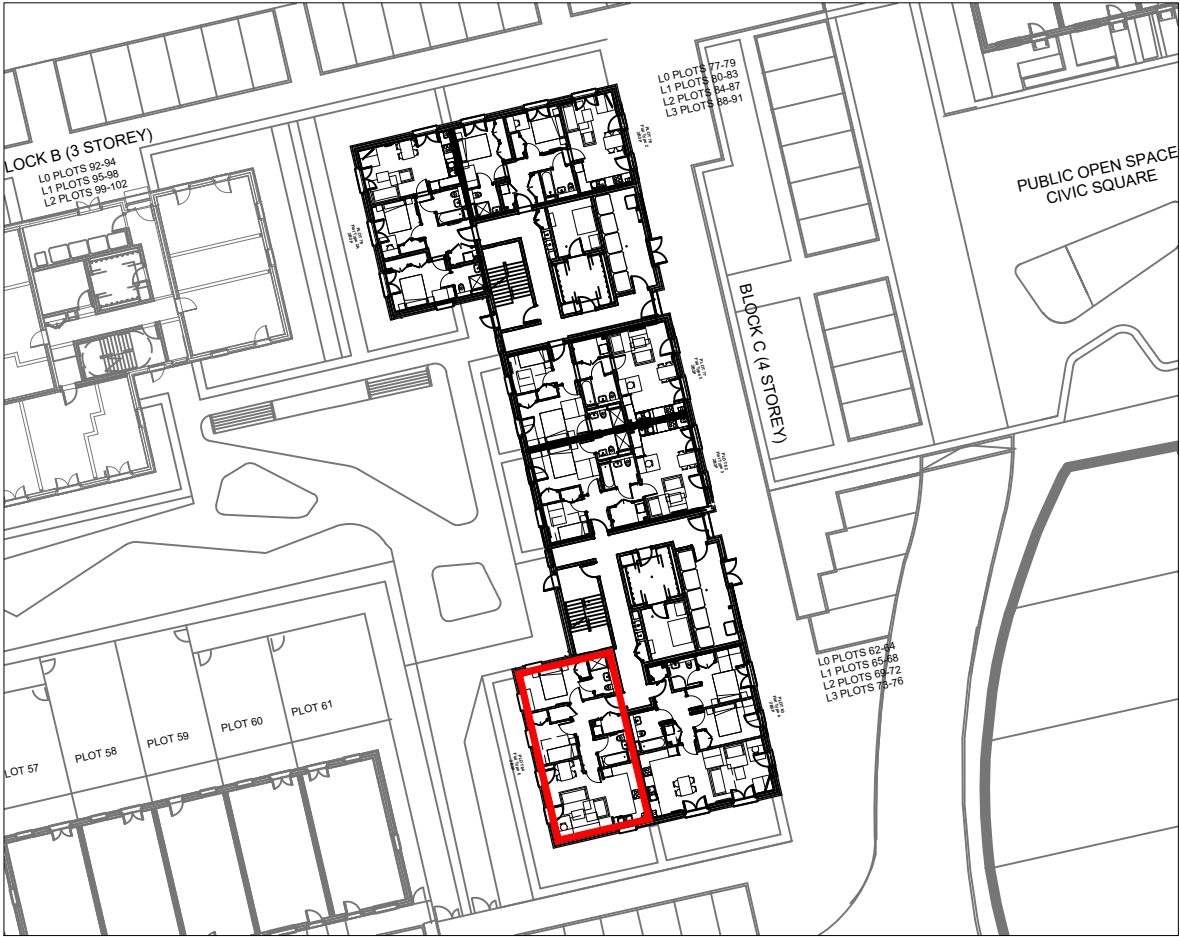

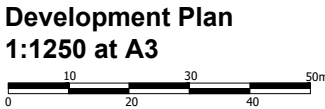
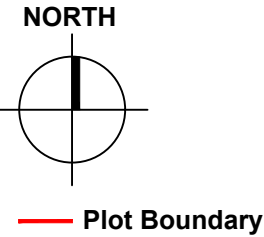

PENNYWELL PHASE 3 - BLOCK C - GROUND FLOOR PLOT 63 TITLE PLAN

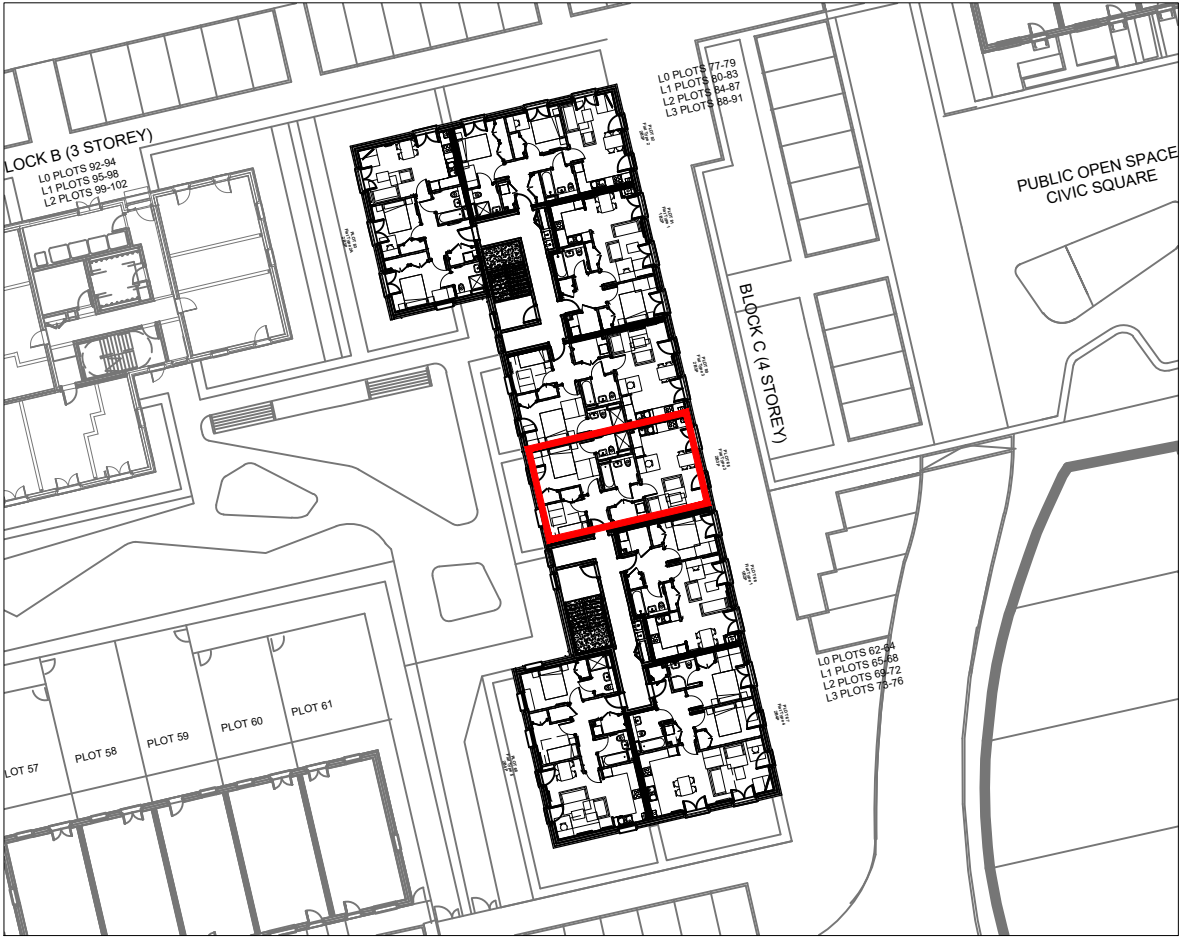

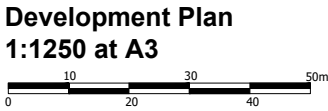
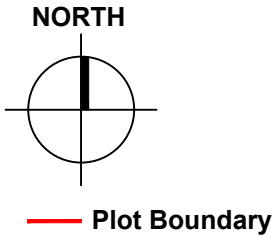

PENNYWELL PHASE 3 - BLOCK C - GROUND FLOOR PLOT 64 TITLE PLAN



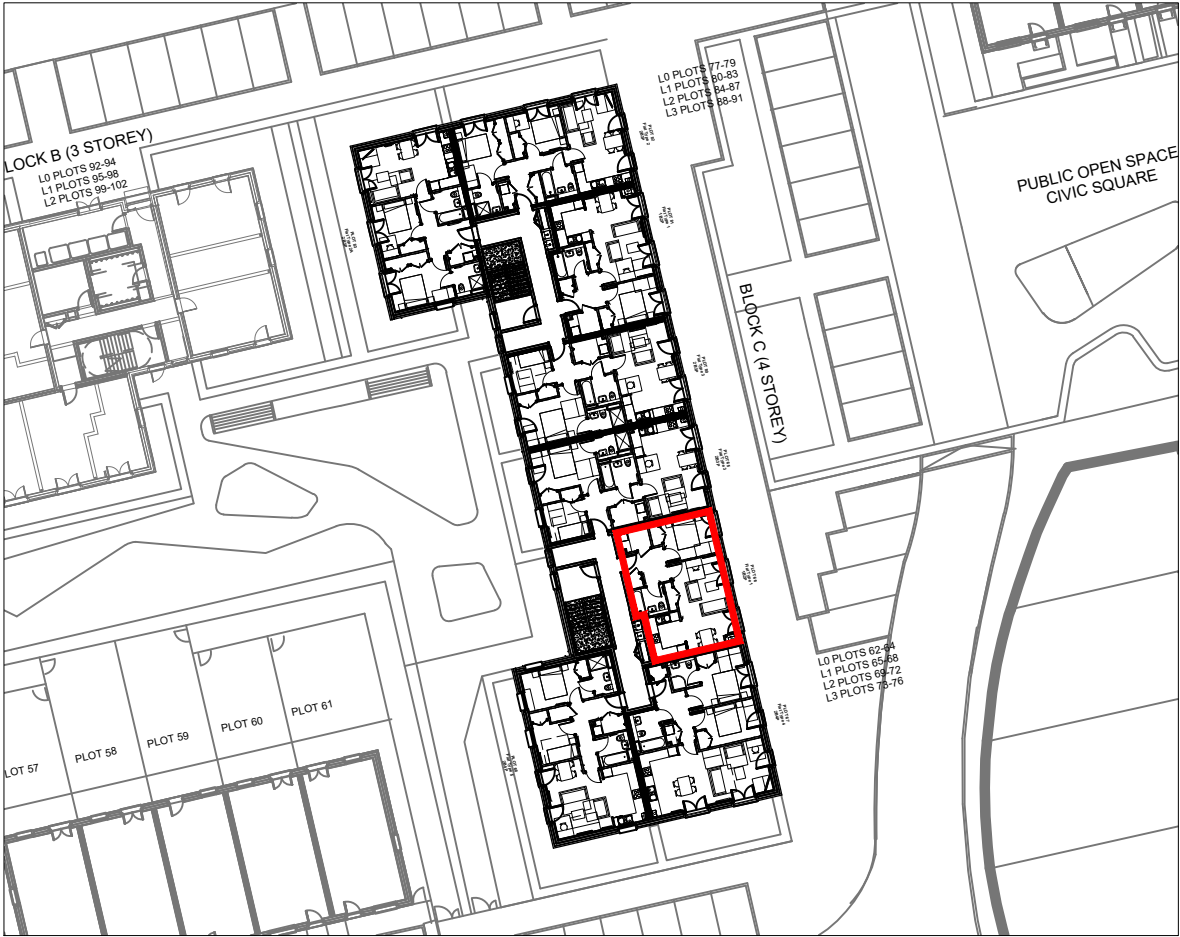

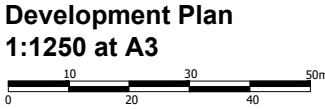
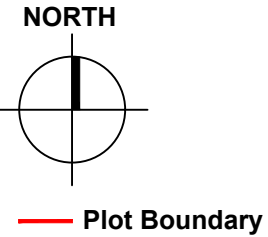

PLOT 65 TITLE PLAN**



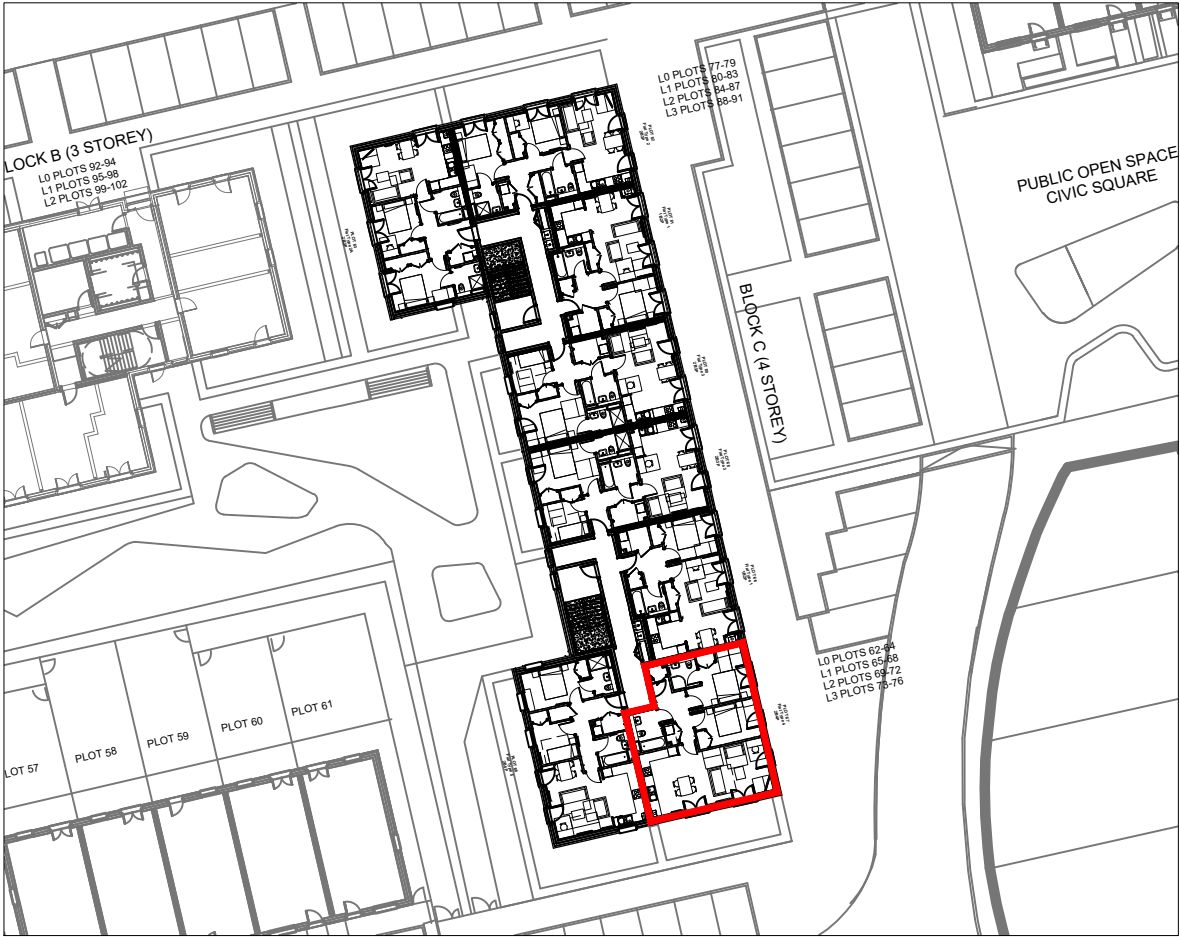

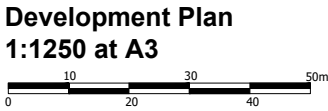
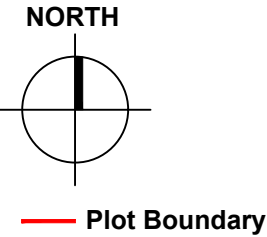

PENNYWELL PHASE 3 - BLOCK C - FIRST FLOOR PLOT 66 TITLE PLAN



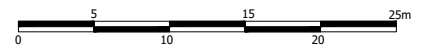
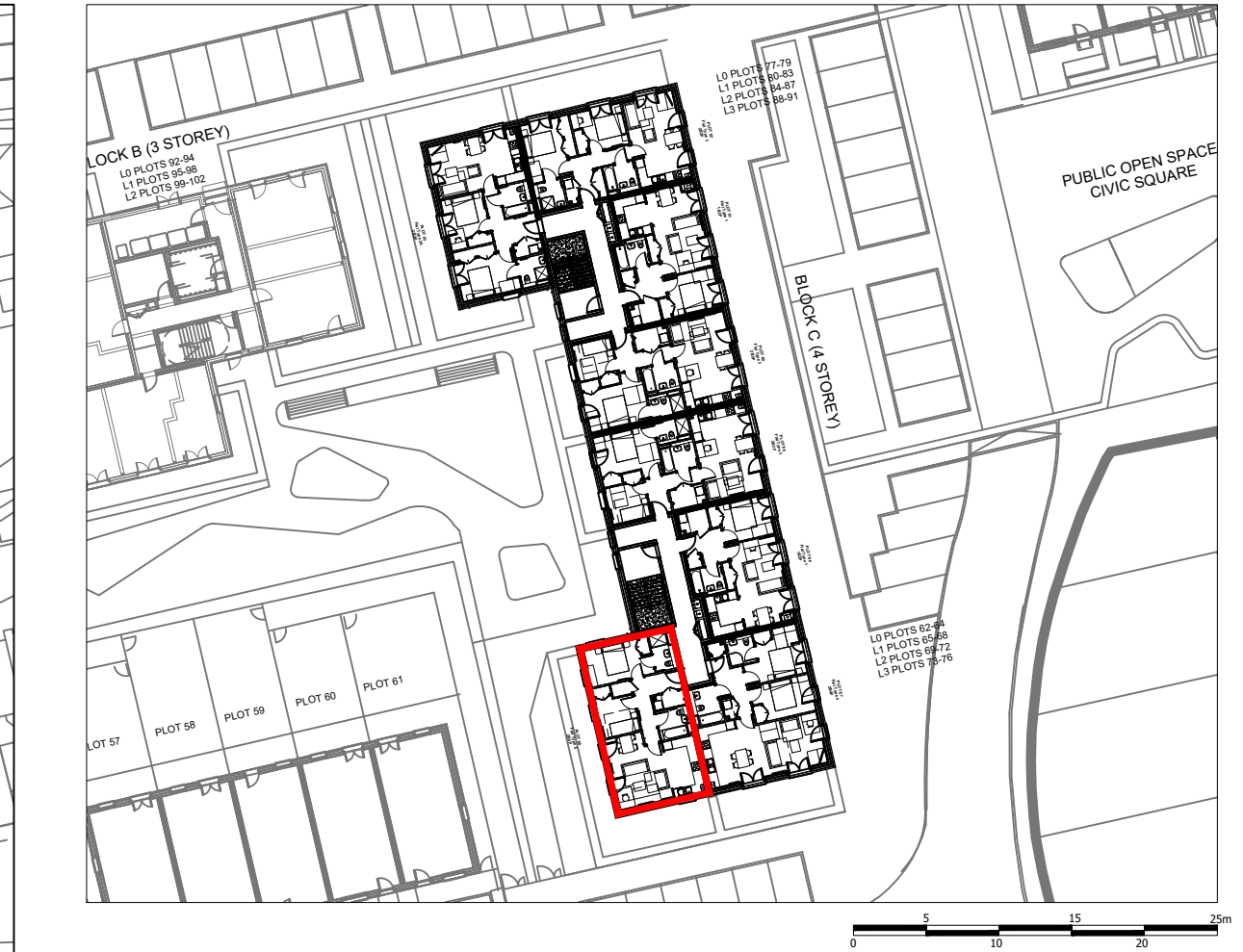

PLOT 67 TITLE PLAN**

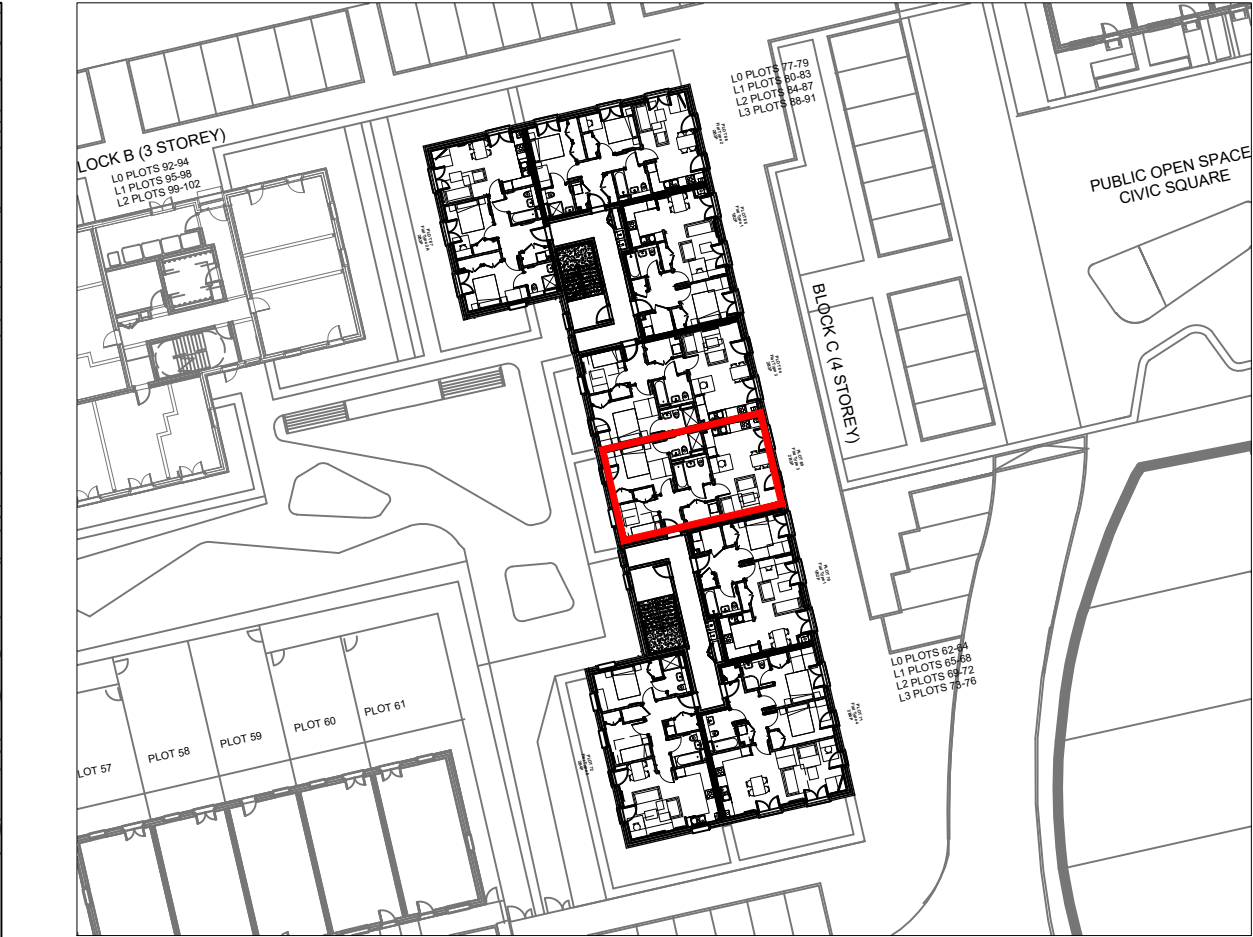

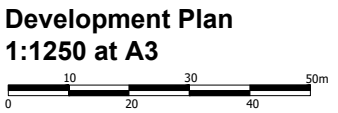
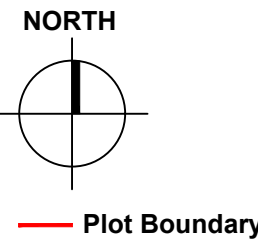

PENNYWELL PHASE 3 - BLOCK C - FIRST FLOOR PLOT 68 TITLE PLAN



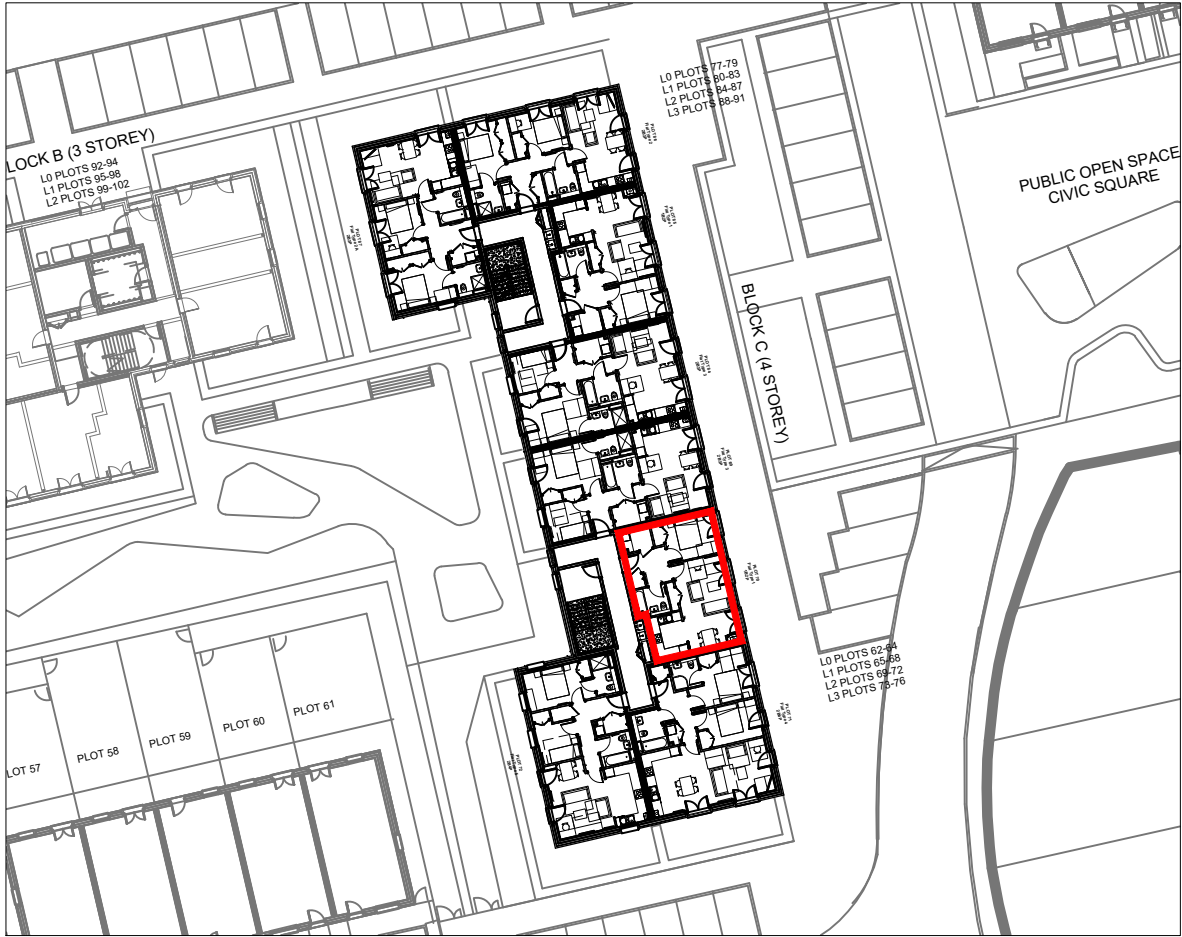

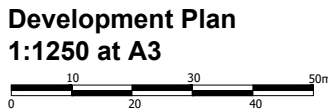
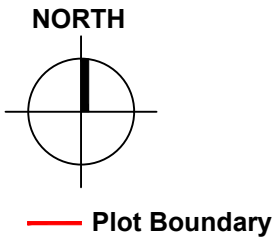

PENNYWELL PHASE 3 - BLOCK C - SECOND FLOOR PLOT 69 TITLE PLAN

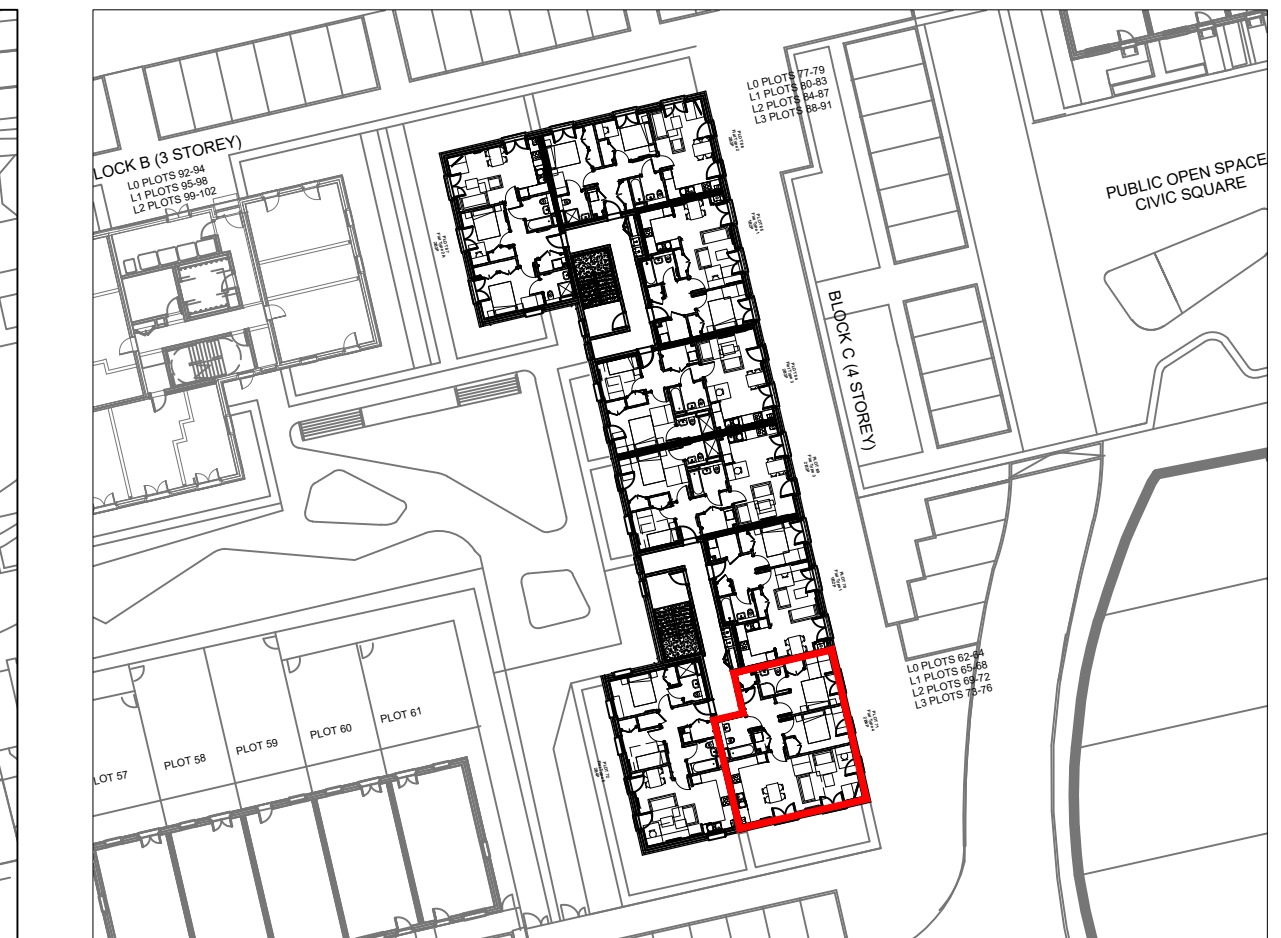

PENNYWELL PHASE 3 - BLOCK C - SECOND FLOOR PLOT 70 TITLE PLAN

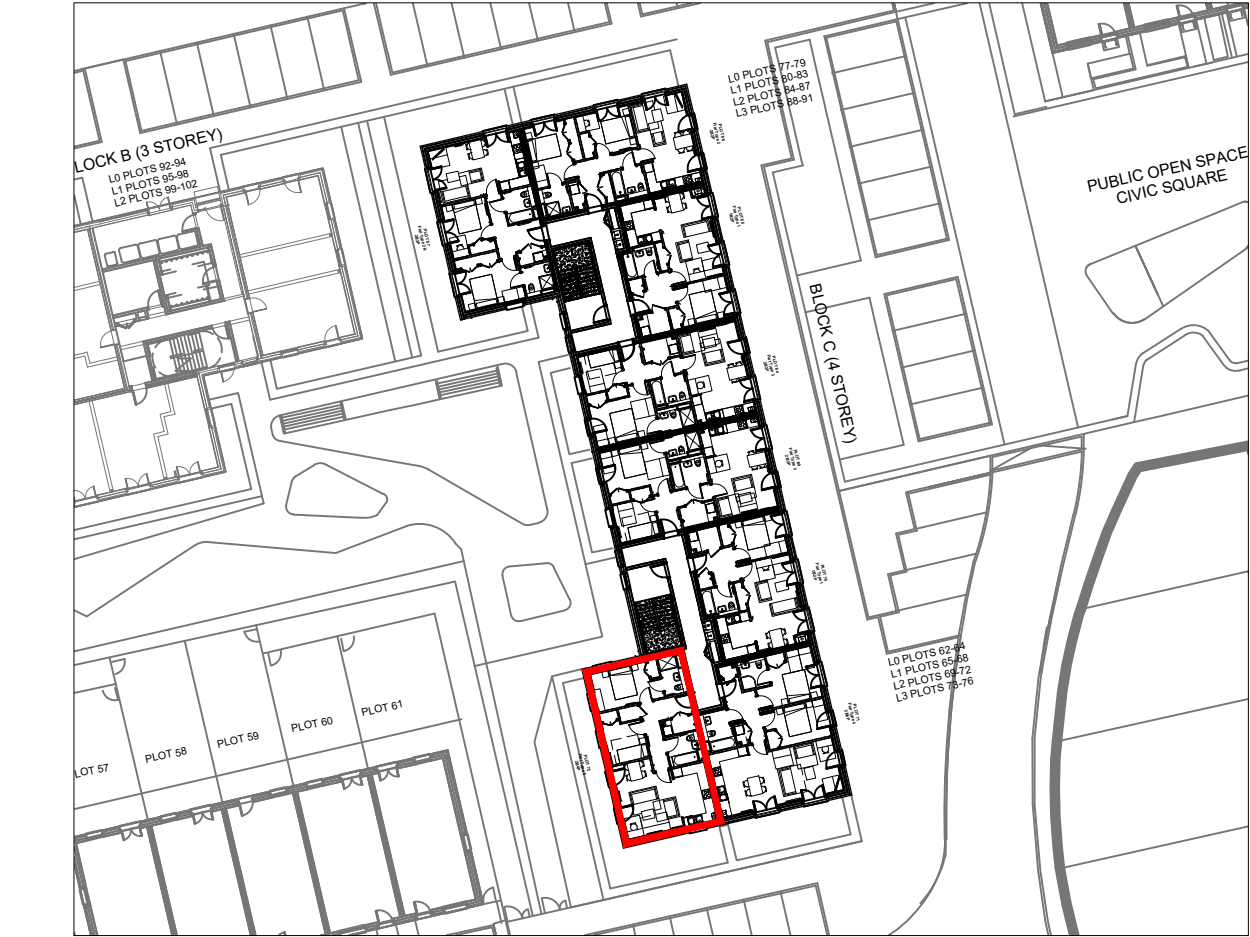

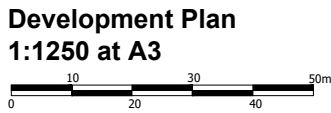
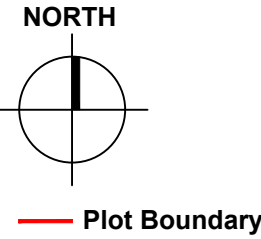

PLOT 71 TITLE PLAN**



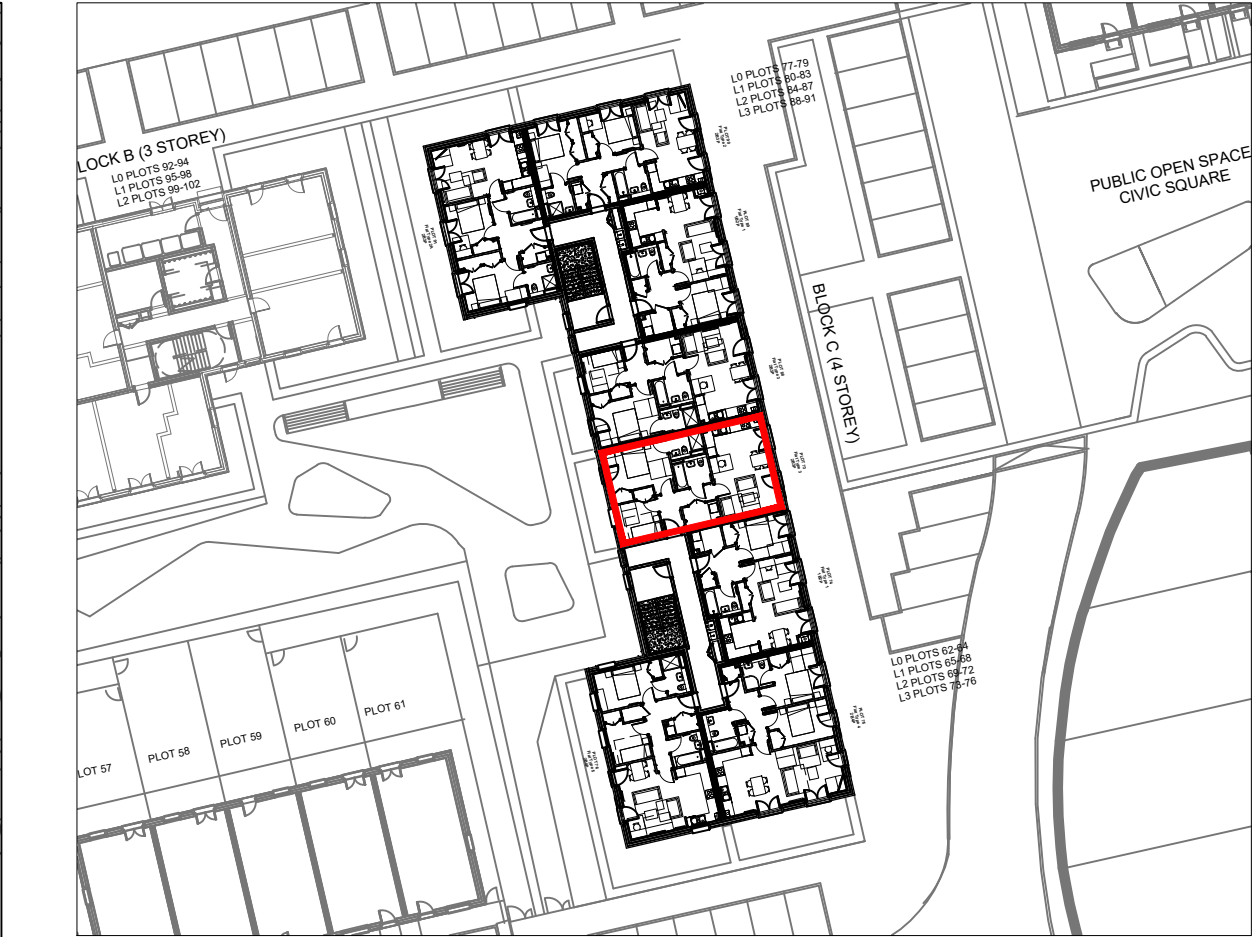

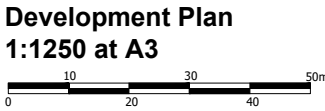
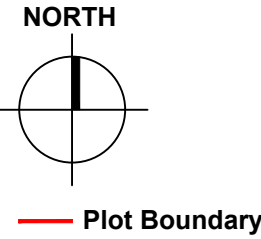

PENNYWELL PHASE 3 - BLOCK C - SECOND FLOOR PLOT 72 TITLE PLAN



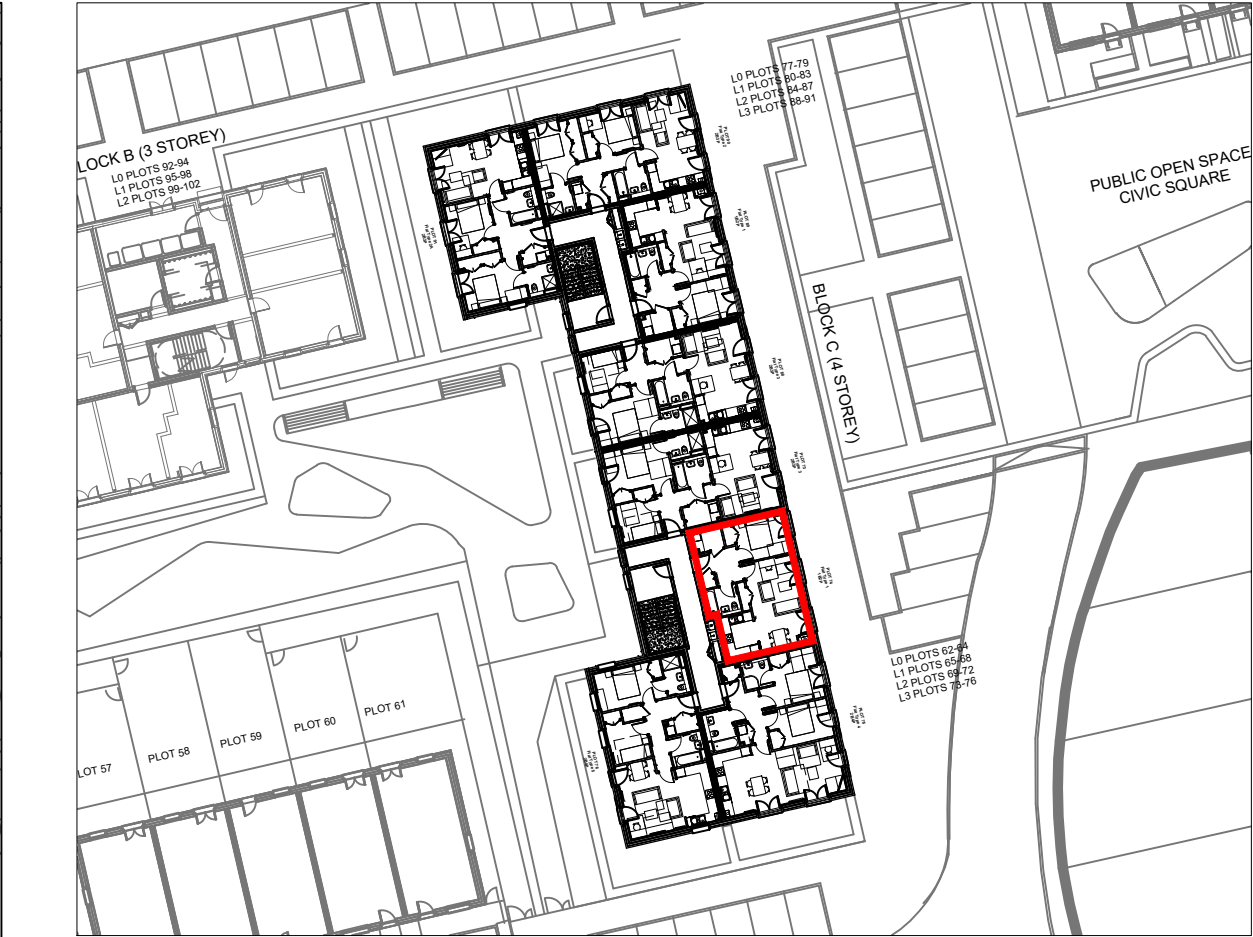

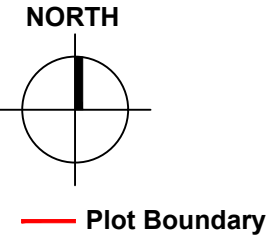

PENNYWELL PHASE 3 - BLOCK C - THIRD FLOOR PLOT 73 TITLE PLAN

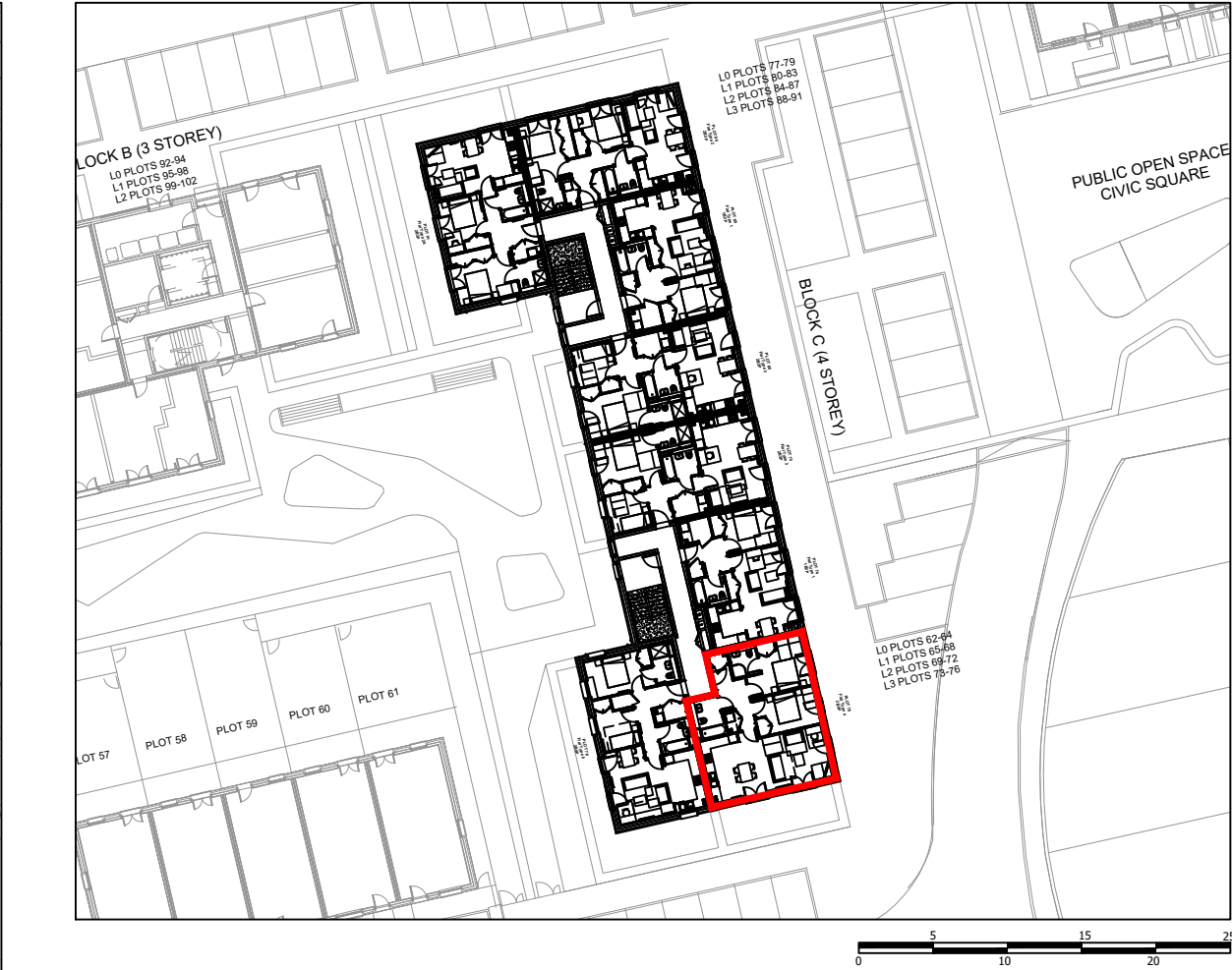
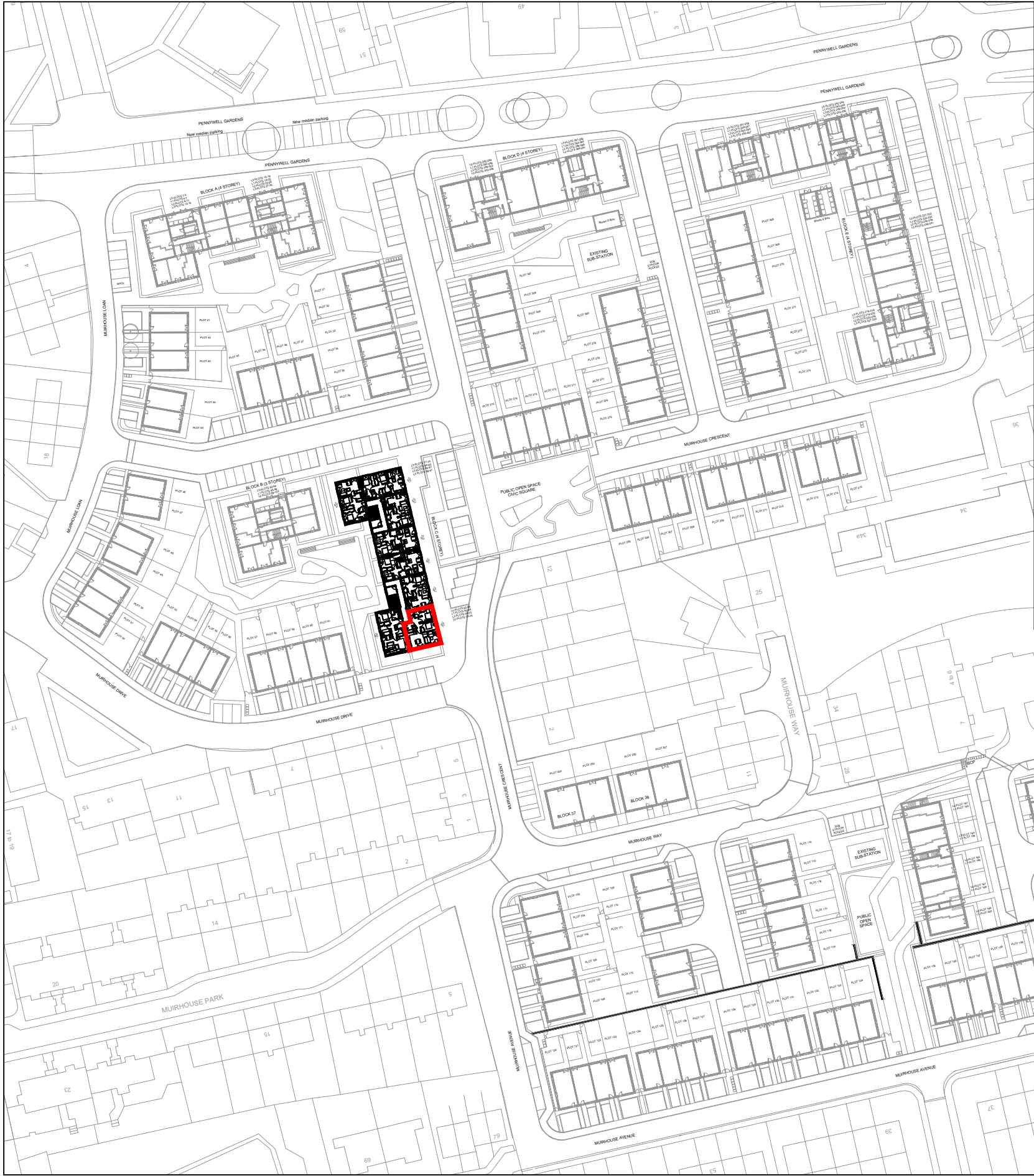

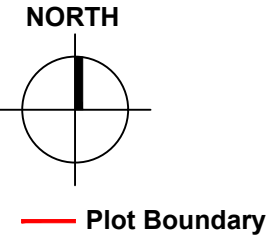

PENNYWELL PHASE 3 - BLOCK C - THIRD FLOOR PLOT 74 TITLE PLAN

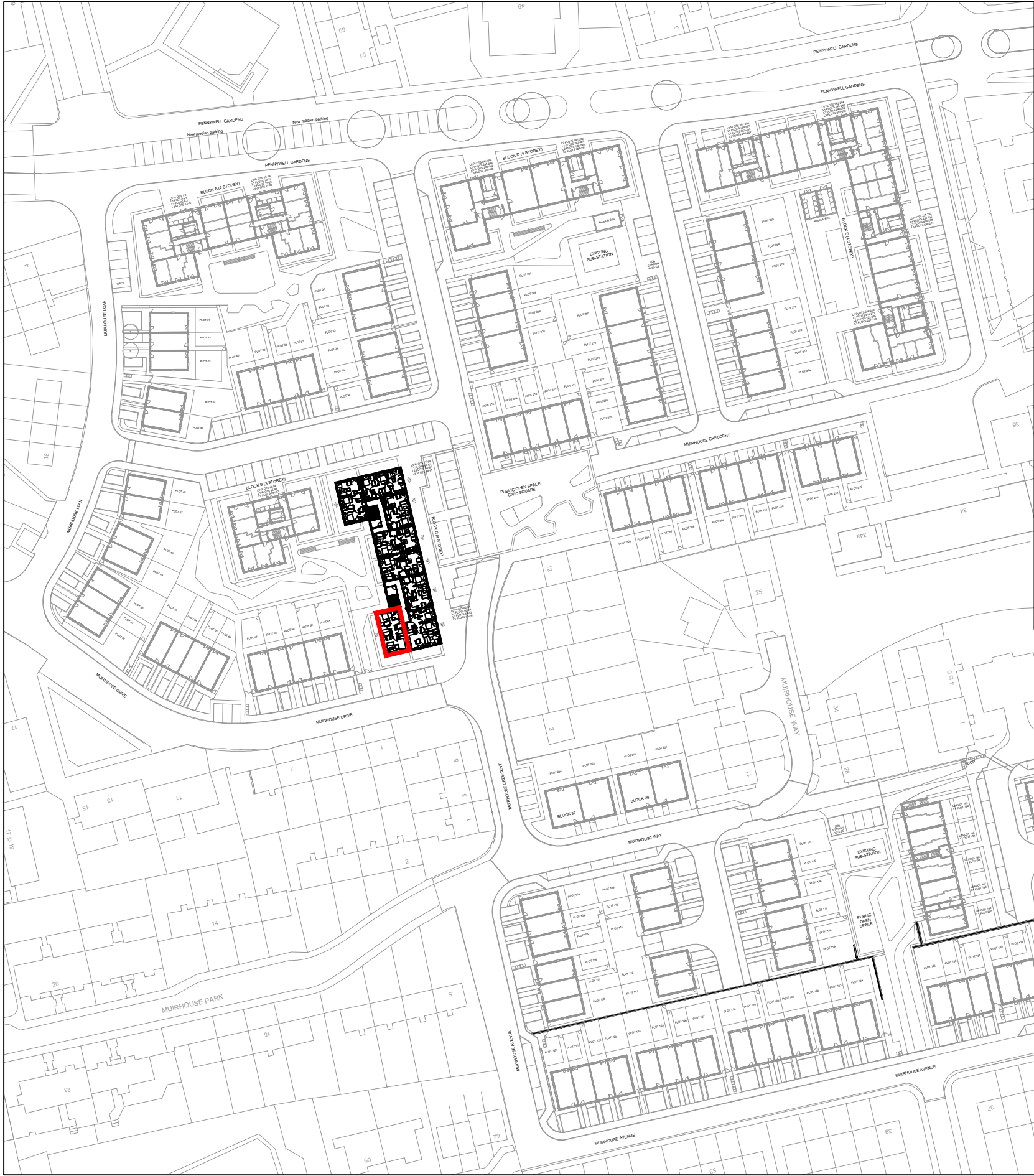

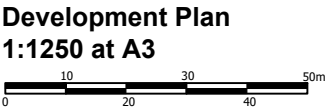
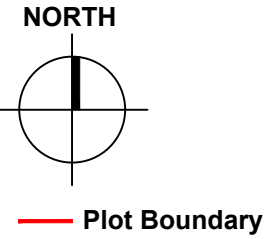
