## Guidance on how to complete the ID forms

If you are completing this form by hand, please complete this form in **black ink** and BLOCK CAPITAL LETTERS. All forms must be signed in black ink.

To guard against fraud, we need to confirm the identity of anyone who is a party to an application for registration where the applicant is not a solicitor or does not have a FAS account.

Each party to a deed and (if not a party to that deed) the applicant must complete a separate ID form which must be verified by an Authorised Certifier. The list of professions which can act as Authorised Certifiers is provided below.

All pages of the form must be returned, however, you need only complete:

PART A - if you are a private individual; or

**PART B** - if you are acting on behalf of a Corporate Body. If you are acting on behalf of a Corporate Body you must be a director, company secretary or be able to evidence that you are an authorised signatory for that Corporate Body.

You must submit your application for registration no later than 6 months after the ID form has been signed and completed.

### **Authorised Certifiers**

#### Who can be an Authorised Certifier?

## Will RoS carry out further checks?
